**A RESOLUTION OF THE CITY OF CARLOS, DOUGLAS COUNTY, MINNESOTA,  
PROVIDING FOR THE SUMMARY PUBLICATION OF ORDINANCE NO. 2025-12-11,  
AN ORDINANCE AMENDING THE CARLOS CITY CODE TITLE XI, CHAPTER 114  
REGARDING TOBACCO REGULATIONS**

**WHEREAS**, on December 11, 2025, at a regular meeting of the Carlos City Council, by majority vote, the City Council adopted Ordinance No. 2025-12-11 which amends Title XI, Chapter 114 Tobacco Regulations of the City of Carlos, Minnesota; and

**WHEREAS**, State law requires that all ordinances adopted be published prior to becoming effective; and

**WHEREAS**, the City Council for the City of Carlos has determined that publication of the title and a summary of Ordinance No. 2025-12-11 would clearly inform the public of the intent and effect of the Ordinance; and

**WHEREAS**, the City Council for the City of Carlos has reviewed the summary of Ordinance No. 2025-12-11 attached and incorporated herein as **Exhibit A**; and

**WHEREAS**, the City Council for the City of Carlos has determined that the text of the summary clearly informs the public of the intent and effect of Ordinance No. 2025-12-11.

**NOW THEREFORE BE IT RESOLVED**, the City Council for the City of Carlos hereby:

1. Approves the text of the summary of Ordinance No. 2025-12-11 attached as **Exhibit A**.
2. Directs the City Clerk to post a copy of the entire text of Ordinance No. 2025-12-11 in all public locations designated by the City Council.
3. Directs the City Clerk to publish the summary in the City's legal newspaper within ten days.
4. Directs the City Clerk to file the executed Ordinance upon the books and records of the City along with proof of publication.

**Ordinance Summary**

**SUMMARY PUBLICATION OF ORDINANCE NO. 2025-12-11, AN ORDINANCE  
AMENDING THE CARLOS CITY CODE TITLE XI, CHAPTER 114 REGARDING  
TOBACCO REGULATIONS**

On December 11, 2025, at a meeting of the Carlos City Council, by majority vote, the City Council adopted Ordinance No. 2025-12-11 which amends Title XI Chapter 114 Tobacco Regulations of the City of Carlos, Minnesota, updating the city's regulation of the sale of commercial tobacco products, tobacco-related devices, electronic delivery devices, and nicotine or lobelia delivery products. The amendment includes sections on Purpose and Intent, Definitions, License, Fees, Basis for Denial for License, Prohibited Sales, Responsibility, Compliance Checks and Inspections, Exceptions and Defenses, Violations and Penalties, Severability, and Effective Date.
